










#### Continuous increase in German ODA to Health 2002 - 2016



# Cooperation countries and regional programmes of German bilateral cooperation in health; 2019



#### BMZ's bilateral and multilateral engagement in health

- The new strategy BMZ 2030 aims at making German development cooperation more effective and strategic and is strongly focused on multilateralism
- Commitment to health systems strengthening and UHC
- Support of efforts undertaken under the Global Action Plan (GAP) for Healthy Lives and Well-being need to establish a well coordinated global health architecture
- Strengthen collaboration with WHO to support its leadership and coordination role together with other key organisations
- Continuation of bilateral health programmes while strengthening linkages to multilateral engagement
- Strengthening One Health approach as a central element of pandemic preparedness

### BMZ – Immediate bilateral and regional COVID-19 response

#### 21 Mio. EUR Health funds reprogrammed

- Bilateral: Cambodia, Cameroon Ethiopia, Kyrgyzstan, Cambodia, Malawi, Nigeria, Nepal, Liberia, Tajikistan, Togo
- Regional: EAC, ECOWAS
- Epidemic preparedness team: Missions to Namibia (Mar), Benin (April); Nepal (Apr, remote); Colombia (May), Ecuador, Peru (tbd)

## **58 Mio. EUR** Humanitarian funds reprogrammed

- Broader support incl. water & sanitation, nutrition, education
- Top-up for Fast Epidemic Preparedness Team



### BMZ – Immediate multilateral COVID-19 response

#### **Global Fund**

- Time bound COVID-19 reaction mechanism of 500 Mio. USD
- Up to 5% of existing HIV/Tb/Malaria grants eligible for reprogramming

#### **Global Vaccine Alliance**

- 10% of HSS programme titles eligible for reprogramming
- BMZ announced top-up of the GER contribution of 600 Mio. EUR 2021-25

#### **Pandemic Emergency Financing Facility**

195,8 Mio. USD disbursed through insurance window in 2 tranches

## BMZ – Medium-term COVID-19 response through redirection and additional funds - 1 bn. EUR

5) Additional economic support for enterprises in key industries such as textiles and tourism	115	400
6) Government liquidity	150 <sup>2</sup>	350
