Summary:

To assess progress towards universal health coverage, countries like Cambodia require evidence on equity in the financing and distribution of health care benefits. This evidence must be based on the system-wide perspective that recognizes the complex roles played by the public and private sectors in many contemporary health care systems. This study aims to undertake a system-wide assessment of who pays and who benefits from health care in Cambodia and to understand the factors influencing this.

The objective of this analysis commissioned by the Providing for Health Network (P4H) upon the request of the Department of Planning and Health Information (DPHI) of the Ministry of Health (MoH) is to estimate the costs of expanding social health protection coverage through an integrated scheme approach. Specifically, the approach entails voluntary enrolment of the non-poor informal sector in Health Equity Funds (HEFs), which currently provide nationwide coverage to the poor.

Abstract:

Improving financial access to services is an essential part of extending universal health coverage in low resource settings. In Cambodia, high out of pocket spending and low levels of utilization have impeded the expansion of coverage and improvement in health outcomes. For twenty years, a series of health financing policies have focused on mitigating costs to increase access particularly by vulnerable groups. Demand side financing policies including health equity funds, vouchers and community health insurance have been complemented by supply side measures to improve service delivery incentives through contracting.
