- **Cote d'Ivoire**, Code of public health, hospital reform, general health inspectorate, control and regulation of health facilities of private sector

❑ Next projects in 2018

- **Guinée** PASA2 = 12,5 M€;

❑ On going project

- **Tchad Mother and child** health ; training in situ of nurses, obstetricians, through french practitioners (AP-HP + CHU Poitiers, Annecy, Planning familial..);
- **Mother and child health in Mali** , Mopti with AP-HP,
- **Congo Brazzaville hospital** (CHUB) ; HR organization and training (through EHESP and AP-HP).
- **Laboratories in Guinée** through Instituts Pasteur and Fondation Mérieux,
- Training of 8 plurisectorial Regional teams from MoH in Guinée, for **diagnosis, and sanitary crises management**
- Training in **oncology pédiatrics** in Burkina through GFAOP;
- **Palliative care** in Kenya/Tanzanie through Institut Curie (cancer)

❑ Next projects in 2018

- Training of **inspectors and controllers in health** (medical, pharma, admin) through EHESP, for Sénégal, Tunisie, Gabon, Cote d'ivoire, Dem Rep of Congo).

Essential medicines and health products



❑ On-going projects

- **Pharmaceutical regulations**: Accompanying the reform of the pharmaceutical, strengthening pharmaceutical regulations and supply chain systems in **Ivory Coast** (Inspection with Drug Regulation Authorities)
- **Access studies** on treatment for **pediatric cancer** and diabetes in West and Central Africa
- **Lab supplies PSM**: Strengthening HIV viral load forecast and national supply chains in **Cameroon and Ivory Coast** (OPPERA, Unitaïd)
- **HTA**: Mobilizing experts from **French National Authority for Health** (Haute Autorité de Santé, HAS) on HTA Health Technology Assessment

❑ Next projects in 2018

- **Medisafe** (UE funding) against false medicines in **11 eastern and central africa**.
- **Blood transfusion** in Cameroun and Turquie trough EFS



SUPPLY CHAIN: A PRIORITY for Initiative 7%



- **Short-term technical assistance** : 15 – 20% of ST TA request with > 40 missions and numerous missions to support the writing of concept notes (procurement plan)
- **Long term projects**: priority theme for 2013, 2014, 2016 and 2017 call for proposals; a dozen projects have been funded :
 - 2016: MQAS reinforcement for CMS; Innovative technologies for SC integrity (tracking, detection..)
 - 2017: National Control Quality Lab reinforcement in West Africa

ESTHERGAS - Development of **Logistic Management and Information System (e LMIS)**

- The 5% Initiative Channel 2: 908,330 € (2015-2017)
- Burkina Faso and Benin
- **Objective:** To harmonize the various existing pharmaceutical logistics data systems and ultimately to achieve integrated management of all types of pharmaceutical input within a single national system.
- **Impact achieved:**
 - Strengthened the sharing of logistics and pharmaceutical information and management systems between national vertical programs.



ACAME

- ACAME 1: 771.684 € (2014-2016)
 - Strengthening the quality assurance systems of 11 ACAME member Central Purchasing Agencies to comply with the Global Fund's quality policy
- ACAME 2: 965.677€ (2017-2020)
 - Strengthening the performance of 14 ACAME member Central Purchasing Agencies in the procurement of essential health products of quality

Supporting the social protection systems in health

Scope of intervention:

- Financing mechanisms
- Monitoring, statistical and information systems
- Management and governance of the systems

Supporting the social protection systems in health

Main principles of intervention:

- Provision of **technical assistance** to institutional partners (ministries, social protection organizations, ...)
- Mobilization of **practitioners** (from EU and South)
- **Peer-to-peer** approach
- **Co-construction** of solutions corresponding to national specificities
- Collaboration based on **strong commitment of local** (government) partners to implement a UHC system
- Nature of intervention depending of the level of development of the systems



Supporting the social protection systems in health

Projects mainly implemented in Africa (but not only), financed by different donors, implemented in the framework of different instruments:

- **Senegal:** assistance provided for the development of an information system for the management of the health insurance system (*financing: I3S*)
- **Congo Brazaville:** elaboration of preliminary studies for defining the Medicare basket for the UHC system and its financing (*financing: Afd*)
- **West Africa region:** Strengthening the management of health care mutuals (*financing: French health care mutual*)
- **Gabon:** elaboration of preliminary studies for the extension of the social protection system to the whole population (*financing: Afd*)
- **Morocco:** Provision of TA to the ANAM in its role of governance of the basic health care coverage (*financing: EU*)

Supporting the social protection systems in health

sociEUX+

EU expertise on social protection,
labour and employment

SOCIEUX+: Expertise facility financed by EU, France, Belgium and Spain

An uncomplicated, quick, and flexible cooperation facility that combines:

- Short-term, peer-to-peer technical assistance provided by experts drawn primarily from the public administrations of EU Member States
- Triangular cooperation, by relying on international expert teams that combine European and non-European practitioners
- Its synergetic, peer-to-peer approach ensures a tailored, to-the-point, technical cooperation
- SOCIEUX+ actions take form of a single or several short-term activities which are in general implemented onsite.
- Furthermore, SOCIEUX+ includes Knowledge Development activities to capitalise the results of actions carried out in the framework of the Facility
