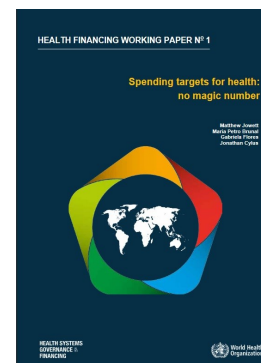

Summary

[...] The scaling up of HEF coverage has been supported by a process of research and analysis of their effectiveness, although some gaps in the literature remain.[...] The study aimed to assess the impact of the HEF system on utilisation of services at Referral Hospitals and Health Centres nationally. It used measures of health service utilisation as the most accurate indicator of access to health care available in existing national data.
