# Monitoring for UHC - putting Cambodia in the driving seat

The Government of Cambodia embarked on Universal Health Coverage (UHC) with the endorsement of the National Social Protection Policy Framework in July 2017. To monitor the implementation of the National Social Protection Policy, the National Social Protection Council (NSPC) and associated structures, the Executive Committee and General Secretariat (GS NSPC), have been established.

The Word Health Organization and Word Bank jointly released a common framework for monitoring progress towards UHC (Sustainable Development Goal indicator 3.8) that recommends focusing on coverage with essential health services together with a degree of financial risk protection. These two measures are interrelated and should be

"Primary health care (PHC), codified at the historic 1978 Alma Ata Conference, was advocated as the means to achieve health for all by the year 2000.1 The principles of PHC included universal access and equitable coverage; comprehensive care emphasising disease prevention and health promotion; community and individual participation in health policy, planning, and provision; intersectoral action on health determinants; and appropriate technology and cost-effective use of available resources." **Read more**

### **Description:**

"One way to achieve universal health coverage (UHC) in low- and middle-income countries (LMIC) is the implementation of health insurance schemes. A robust and up to date overview of empirical evidence assessing and substantiating health equity impact of health insurance schemes among specific vulnerable populations in LMICs beyond the more common parameters, such as income level, is lacking. We fill this gap

by conducting a systematic review of how social inclusion affects access to equitable health financing arrangements in LMIC." **Read more** 



"A Legal and Regulatory Assessment of Private Healthcare Provision in Cambodia: Private Providers' Perceptions"

### **Description:**

"Cambodia's private healthcare sector is the first point of contact for most Cambodians within the health system and, as such, plays an important role in increasing access to health services. However, the current policy and regulatory environment is oriented more toward the public sector.
