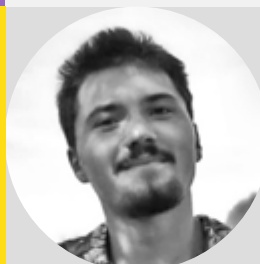

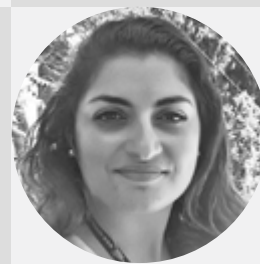

Since 2019, she has been a member of the Council in the Vasco de Gama youth movement (WONCA) and in 2021 was elected as a member of the Council at the European Academy of Teachers in Family Medicine (EURACT).
