



6th Meeting of the Montreux Collaborative on Fiscal Space, Public Financial Management and Health Financing

Adjusting PFM for better health: evidence to shape next-generation reforms

13-17 NOVEMBER 2023 MONTREUX, SWITZERLAND





OVERVIEW

Since 2014, WHO has convened biennial meetings of the Montreux Collaborative, bringing together experts and partners to discuss the critical relationship between fiscal space, public financial management (PFM), and health financing in advancing universal health coverage (UHC). The aim is to raise the profile of public finance's role in achieving UHC, to generate and exchange ideas and lessons to support the implementation of tailored reforms in the health sector, and to consolidate and broaden the network of experts and partners interested in public finance issues for health.

The 6th meeting of the Montreux Collaborative will take place from 13-17 November 2023, with the theme *Adjusting Public Financial Management (PFM)* for better health: new evidence to shape next-generation reforms.

As with prior meetings, this year's event is organized in close collaboration with partners involved in this area of work, including the World Bank Group, the International Monetary Fund (IMF), the Organisation for Economic Co-operation and Develoent (OECD), the United Nations Children's Fund (UNICEF), Gavi, the Vaccine Alliance (Gavi), the Global Fund to Fight AIDS, Tuberculosis and Malaria (the Global Fund), International Budget Partnership (IBP), Results for Development (R4D), and ThinkWell.

OBJECTIVES

- Take stock of lessons from COVID-19 for PFM and health financing reform, and identify PFM features conducive to resilient systems;
- Deepen the understanding of PFM requirements for effective financing of primary care;
- Unpack health budget execution challenges and discuss joint solutions between finance and health.

More broadly,

- Identify gaps and needs to accelerate countries' implementation of PFM reforms;
- Enhance coordination among key partners involved in this area of work;
- Gather strategic inputs to inform the PFM-for-health agenda of the future.





PROGRAMME

The meeting consists of three main parts.

- Day 1 is a pre-event workshop on direct financing of health facilities. The workshop is an invitation-only event organized by WHO, in collaboration with the World Bank Group, the Global Fund, and Gavi, involving contributors to a WHO "How-To" manual on this topic.
- Day 2-4 is the main event. It is structured around core technical sessions (available both inperson and on-line), with optional seminars over breakfast and lunchtime (in-person only).
- Day 5 is a post-event half-day session focused on the transition from external aid and its implications for domestic budgets, jointly organized by WHO, the Alliance for Health Policy and Systems Research, and UHC2030. It is by invitation only.

LOGISTICS

The 2023 Montreux Collaborative meeting will be hybrid, held both in-person and online. The meeting venue is the <u>Eden Hotel</u> in Montreux, Switzerland.

Given the limited capacity for in-person attendees, preference for in-person participation will be extended to presenters and to participants officially appointed by their respective governments. Unless notified directly by WHO, all other interested parties are invited and welcome to attend the meeting online, with the agenda providing many opportunities for interaction for both in-person and online participants.

Connection details for online participants will be provided via the Montreux Collaborative distribution list and can be shared with other interested parties. Online participants do not need to register in advance.

Governments will officially nominate representatives for in-person participation via the relevant WHO country office. WHO will provide logistical and financial support for travel and accommodation for these participants. Hotel rooms have been pre-booked for all sponsored participants.

Logistics notes will be shared with in-person participants in June 2023.

Day 5 – 17 November 2023 – Transitioning from external aid: implications for domestic budgets

This invitation-only, half-day session will bring together country representatives and development partners to delve into the issue transitioning from external aid for health and the implications of these transition processes for domestic budgets. Concrete country experiences will be shared based on the WHO Health Financing, Alliance for Health Systems and Policy Research, and UHC2030 programme of work on "Transition from external assistance." The session will also broaden to consider how to align external assistance for health with domestic budgeting processes, priorities and best practices. The objective of the half-day session is to identify actions that can be taken at country level that promote sustainable coverage of externally supported interventions and services.
